Statistics Request Overall Description

On December 21, 2016, Ed C Monahan of the Department of Public Advocacy, requested from Research and Statistics a statewide count of expungement petitions, expungements granted and expungements denied since July 15, 2016 by county. CourtNet, which provides a summary of Kentucky court cases, was queried statewide for documents filed of the types indicated below from July 15, 2016 through December 31, 2016.

The original expungement process in Kentucky, which existed prior to July 15, 2016, allows for the application of expungements for convictions of traffic violations or misdemeanors, felony charges not resulting in indictment, charges acquitted, or cases dismissed. The document PEXA is used to apply for the expungement of acquittals, dismissed cases, or felony charges not resulting an indictment. The document code PEXC is used to apply for the expungement of misdemeanors and traffic violations. When either of these types of expungement is granted, a document of type OEXG is filed, and when either of these types of expungement is denied, a document type OEXD is filed. However, the data regarding these documents included in CourtNet does not specify the charge or type of disposition that is being expunged. Thus, it cannot be determined in aggregate how many of the expungements of these types granted or denied apply to convictions vs. other dispositions or the level of the charge expunged.

Statistics Request Overall Description

In conjunction with the new felony expungement law that came into effect on July 15, 2016, a separate track was created for the expungement of Class D felony convictions and for offenses that receive executive pardons. The document AFEX is used for the application for such expungements, the document OFXG is used when such expungements are granted, and the document OFXD is used when such expungements are denied.

Statistical Tables (17 RS8000)

Cross-tabulation Tables:

The report contains two cross-tabulation tables. The first table includes documents associated with the expungement of Class D felony convictions and pardoned convictions, and the second table includes documents associated with all other expungements.

Each table includes counts cross-tabulated by county and document type, with counts of distinct cases as well as the total number of each document type. The 'Total' column includes counts of distinct cases across all document types. Statewide totals are included at the bottom of each table. It should be noted that some of the petitions filed during this timeframe may still be pending, and the applications for some of the reported expungements granted or denied were filed prior to the timeframe.

To provide a more complete picture of the overall number of statewide expungements, the AOC Records department reports that they issued 6,207 expungement certificates issued from July 15, 2016 to December 31, 2016 through AOCFastCheck. The expungement process starts with the purchase of this certificate, and then the expungement requirements are evaluated. Some defendants may become aware that they are not eligible for expungement after the filing of this certificate but before moving far enough into the process to receive an official denial, as they may cease their application at this point to avoid paying further fees.

Statistical Analysis Considerations:

- The statistics presented in the attached tables are a snap shot in time.
- CourtNet data matches expungement documents to a given case number, but is not linked to any given charge. As such, aggregate CourtNet data cannot be used to differentiate the types of expungement petitions, expungements granted, or expungements denied apart from the distinction between Felony D conviction and pardoned offense expungements as opposed to all other expungements.
- When a case or charge is expunged, an automatic process within the software creates the appropriate OEXG or OFXG. In many cases, clerks unaware of this have manually created duplicate entries of OEXG or OFXG documents, and for this reason, counts of granted expungements may be artificially high.
- Some expungements may be issued by court order without defendants having gone through the application process, meaning that some expungements granted may not have associated petition documents.
